



## **Covenants Within Contracts**

### **The Birth Experience**

The possibility exists that a doctor, nurse, midwife, or other individual involved in your birth or your children's birth was working for the powers of darkness and may have quietly, unobtrusively made a dedication of you or your child that was unholy. In Asia and Africa, this is more overt or more prominent or dominant in Westernised nations, but there is still the possibility this existed for you. This may have been done without your knowledge or permission.

Secondly, a protocol exists in Western nations that involves drawing blood from the newborn and sending it to a lab for blood tests. It is a simple matter for a lab tech to take some of the newborn's blood (or your blood) and make a blood covenant without your knowledge or permission.

Thirdly, the propensity exists for hospital staff to make rules on their own that are not a part of hospital policy. Because of the authority position of the medical staff they often make their own rules without having true authorisation of the executive decision-making personnel of the hospital. This can occur when a hospital staff makes "rules" without the input of the parents or the superiors of the staff person.

These rules can create legal, spiritual standings that affect you or the baby. Mistakes on a person's birth certificate often have spiritual implications for the person. Whether misspellings, wrong dates or measurements, incorrect filings, etc., these can seem to un-anchor the child and create open doors that Satan will exploit to cause trouble in the child's life.

These are ways that the birthing experience can be accessed by the enemy to create hooks in you, in your time, or create covenants that would control you or affect you. These covenants that were made without your permission or knowledge, or the permission or knowledge of your parents and the vulnerability of the birthing experience. Even covenants made without your or your parent's knowledge or permission are still in force until they are dealt with successfully in the Courts of Heaven.

### **Model of Prayer of Release**

I request permission to enter the Court of Cancellations on this day. I ask You to open the book of record of my life containing the record of my conception through 40 days after my

birth. I ask you to identify every person who was involved, everything that was said, written, or thought and particularly bring to light every unholy thing that was attached to me at that time. If any covenants of darkness exist, I ask that they be judged as unlawful as they were probably made without my or my parents' knowledge or permission; they were not my will, not Your will, nor were they entered into by me.

I also present agreements with Sheol that may be in place. I present any dedication that was made. I present any judgments made by doctors, nurses, midwives, or any staff as to what my viability might have been. Any demonic device, brand, mark of ownership, any label that was put on my spirit, soul, or body, I ask You to identify.

I ask that You sit in judgment on the entire birthing process and everything that was done that was not fully legal according to the righteous law of the universe.

I ask You to rule against and destroy the power of these things. According to Isaiah 28, I ask You to annul every covenant that is not righteous and just according to Your law, especially covenants that were made on my behalf or on behalf of my children that I did not know about.

I ask You to destroy the power of every agreement that was made about me, for me, or for my children that is not righteous and just. I ask You to remove every brand, every label, every name that was placed on me or on my children without my or our knowledge, consent, or participation that creates a link to darkness.

I ask You, Your Honour, to scrub the entire birthing experience and all defilement caused by a trauma bond to time, a trauma bond to land, covenants and agreements, and any diminishing or defiling of our birthright and offices. I ask You to cleanse these things.

I ask that the blood of Jesus be applied to my birth, to the birth of each of my children, whether biological children, foster children, or adoptive children. I ask for a purging of the birthing experience with no dedication to darkness, no attachment to darkness, and no trauma bonds to anything unholy. I ask that every false verdict created during this time frame be overturned in the Courts of Heaven and replaced with a righteous verdict on my behalf.

I request this Your Honor, the Righteous Judge of the Universe, who abhors the mingling of light and darkness and desires that I may walk fully free of all the attachments and operations of darkness, in the name of Jesus Christ.
