



## **Covenants Within Contracts**

### **Childcare**

A very popular location in which to impact negatively the lives of children is in childcare. Several arenas of childcare need to be considered: babysitters that our parents hired, church nurseries, and childcare centres.

These persons (and their employees or volunteers) have easy access to affect the lives of children. Believers can affect the children of non-believers and non-believers can affect the children of believers.

### **Model Prayer of Release**

I request permission to enter the Court of Cancellations this day. I ask You to open the book of record of my life containing the record of my birth through the season from my birth to adulthood and every situation where I, as a child, was in the care of another human being; I ask You to examine these situations. I ask You to open the books and see what was done; see every case where we were defiled by the toxicity of others—just by their being close by, their touching, or their speaking, and I ask You to wash me clean from the defilement by these contacts.

Where spirit, soul, or body have been made less pure by contact from impure childcare workers, babysitters, daycare owners or employees, nursery workers or children's church workers (or any other persons who had contact with me including other children, I ask You to wash, cleanse, sanctify my spirit, soul, and body.

Specifically where workers of iniquity have created covenants for any part of my being, my birthright, or office; every place where labels or curses were placed on me; any device that would limit the potential You have designed for me, I ask that You would identify and bring before Your throne. The limitation that was created through word, ceremony, symbol, or act of the will of another person, I ask You to identify. I ask You to sit in judgment on these things and everything that is not true, and right, and just according to the righteous law of the universe, I ask You to destroy, remove the power of them, remove the limitations, annul the covenants, shatter the agreements and release me and my children to fulfill your purposes according to Ephesians 2:10.

I ask that Your will would be triumphant in my life; that every secret thing that was done to me, about me, or for me would be obliterated from my reality and that Your will would be

expressed. I ask that I would not be limited in any way. I ask that no enemy of Yours would be able to siphon off any of my assets or treasures.

I ask that everything You gave me would be restored to me; my potential would be re-established; every limiting device, covenant, curse, oath, or agreement would be shattered and dissolved, so I would be free to walk in the fulness of Your heart toward me.

Your ancient enemy must not define my future. You defined my life before the foundation of the world, and I come into agreement with Your will. I invite Your Kingdom to come and Your will to be done in my life and in the lives of my children. Whatever You envision for me is to be. Everything You have designed for me to receive I am to receive. Everything that was taken away by workers of iniquity is to be restored to me, and I request the full release of these things into my life now. May nothing be robbed, controlled, limited, or suppressed by any person or spiritual entity that does not bow the knee to Jesus Christ of Nazareth.

I ask for just judgment on these things. I ask for angels to destroy every unholy device that is holding us back and I ask You to avenge Yourself on Your ancient enemy by restoring to me over and above what was lost. I request these things, Your Honor and as Your child, in Jesus' name.
