

## **Covenants Within Contracts**

## School

A very fertile ground for workers of darkness is our academic arena. Whether the worker of darkness is an administrator, faculty, teacher, staff member, elected official or other related individual, we (by the defaults built into the educational system) surrender certain of our rights as parents to the school staff and administration, trusting that they have the best interests of the children in mind. I ask You destroy all evil, all agreements; annul every covenant, remove every label, name, or mark of ownership; remove the slavery and the responsibility to serve, obey, or to submit to any demonic entity, any spirit of Leviathan, any spirit of Ahab or Jezebel, or every other unclean spirit that does not bow the knee to Jesus, the Christ of Nazareth. I ask You to their power over me and over my children.

I acknowledge the power of covenants made without my will, but I also acknowledge and proclaim that I have a higher legal ground – the death, burial and resurrection of Jesus Christ on my behalf.

I ask You to free me from all defilement that has come into my life through things I did not know about – through the land, people, and/or buildings of my academic experience and let me be set free to be everything You designed me to be as Your son and as the Bride of Christ. I ask that all covenants, contracts, oaths, vows, or other declarations made without knowledge (or foreknowledge) that are outside of your will for my life be annulled this day. I ask that every covenant of death be dissolved as I submit myself to Your higher covenant of life.

I ask that every false verdict arising from my involvement in the educational system on any level would be uncovered now and overturned and replaced with righteous verdicts on my behalf. I ask that You would search and root out every false belief I was made subject to during this time of my life and where I embraced these lies and deceptions, that You – in Your mercy would uproot them from my life and replace them with Your truth on my behalf.

Where I have allowed a mixture of the holy and the unholy to be planted in the soil of my life, I ask that you uproot that mixture and replace it with pure life and light. Where I have come under the ownership claims of these workers of darkness and the entities empowering them, I request an immediate transfer of title from darkness unto You, the Living God. I request that every lien be marked satisfied by the blood of Jesus. I request that every note be marked satisfied. I request that every outstanding lease agreement be marked satisfied by the blood of Jesus on this day. I choose this day to be subject only to You, the Lord of Hosts.

I ask this in the name of Jesus Christ of Nazareth.
